

# 2009 Summer Concert Series

## *Prize Giveaway Rules and Regulations*

Every Thursday, June 4-August 27

**No Purchase Necessary.** Short Pump Town Center “Summer Concert Series” Giveaway is open to U.S. residents who are at least 18 years of age at time of entry. Void where prohibited by law.

**How to Enter:** Participation in this promotion constitutes your full and unconditional agreement to and acceptance of these Official Rules and decisions of the sponsor which are final in all respects. To enter, fill out an official entry form during the Concert Series at Short Pump Town Center located in the Main Plaza. Entry forms will be available during the Concert Series only, every Thursday, June 4-August 27 (in addition to any rain dates) from 6-8 PM. No photocopied or mechanically reproduced entries will be accepted. All entries must be completed in full and must be handwritten. Entries completed with address labels will not be accepted. All entries must be received in the official raffle bin that will be located at Concert Series in the Main Plaza at Short Pump Town Center every Thursday evening of the event from June 4-August 27 (in addition to any rain dates). All entries received from ineligible entrants will be void. The name of one (1) winner for each prize pack awarded will be randomly selected from all entries collected at Short Pump Town Center each week of the Concert Series. The thirteen (13) weekly winners will be eligible to win one of five autographed acoustic Epiphone guitars.

**Eligibility:** Winner must meet the following criteria: must be at least 18 years of age at time of entry and must be a U.S. resident. Odds on becoming the winner will be determined by the number of entries received. Short Pump Town Center and Forest City Enterprises accept no responsibility for lost, late, illegible, or misdirected entries. Winner must be present at time of drawing. Officials of Short Pump Town Center will conduct the contest. All decisions of Short Pump Town Center will be final. If the winner does not meet eligibility requirements, the prize will be forfeited, and subsequent drawings will be held from the remaining entries collected.
